The constant improvement of victim support and victim protection in Schleswig-Holstein is especially important to the state government and specifically to the Ministry of Justice and Health.

In Schleswig-Holstein, there already are several institutions for victim support and support offers. The Central Contact Point for Victims of Crimes and their Relatives, established by my ministry on July 1st 2020, is an important addition – a central point of contact for victims of crimes.

A team of employees of the Ministry of Justice takes up the questions of all affected people und supports them in the search of suitable help.

At the same time, my ministry named Mrs. Ulrike Stahlmann-Liebelt as Representative of Victim Support for the state of Schleswig-Holstein. She will stand up for all concerns and issues of people affected by crimes and she will contribute, together with the Central Contact Point for Victims of Crimes, to the quick and effective support of victims.

My name is Ulrike Stahlmann-Liebelt. Until June 2020, I was the senior attorney general of the public prosecutor's office in Flensburg and on July 1, 2020, I took office as Representative of Victim Support.

For more than 30 years, victim protection has been an important focus of my work. Among other things, I participated in the development of professional process support for victims of severe crimes, and together with others, I initiated a counseling center in Flensburg for children who have witnessed or experienced domestic violence. During this work, I found it important to involve all parties concerned. I, as Representative of Victim Support, am happy for the opportunity to continue to give impulses and support in this field. As Representative of Victim Support, I see the Central Contact Point as a reliable place of orientation for people in Schleswig-Holstein, who have either been harmed by a crime themselves or have witnessed it with a close person. According to my experiences, these events often go hand in hand with shock and helplessness which brings about the necessity to support the affected people. The possibilities for support and help are structured and centralized by the team of the Central Contact Point so that help can be offered in a personalized and simple manner.
